Application/Permit is only valid from April 1 thru October 31 of each year or until the Director of Public Works determines that a reasonable alternative for discharge is available.

No person shall make connection of roof down spout, sump pump, exterior foundation drains, area way drains or other sources of surface runoff or groundwater to a building sewer or building drain which is connected directly or indirectly to a sanitary sewer.

Applicant/Owner is subject to all requirements of City of Jefferson Municipal Code and will hold the City harmless from all damages, costs and charges that may accrue related to the permitted discharge of clear water. Application is hereby made for a permit to discharge clear into the City right of way under the City of Jefferson Municipal Code § 232-33 A-F.

I further certify that I have read the Ordinance § 232-33 and will comply with the Ordinance and all other local, state and federal regulations. I hereby certify that I will hold the City harmless from all damages, costs and charges that may accrue related to discharging the clear water. I also understand and certify that I will correct my drainage issues that cause me to need to discharge clear water to the public right of way. I also understand that I may not be permitted in the future if I fail to correct or show significant effort to try to correct the problem that I have on my property. The City is granting this limited discharge permit through the exercise of the City's discretion. I understand that I may not be permitted in the future. I understand that as permit holder I shall be responsible for and have the duty to insure the area is maintained in a safe condition. I recognize that this permit is for the period of April 1 through October 31.

Permission: I hereby give the City permission to enter and inspect the property at reasonable times, to evaluate this application/permit, and to determine compliance with any resulting permit coverage.
