WHEREAS, the City of Jefferson solicited bids to strip paint & plaster, fix any structural repairs and resurface the Jefferson Family Aquatic Center and

WHEREAS, due to the specialization of this process, we received a response from one vendor: and

WHEREAS, the bid was from Sonseeker Pool Masonry, LLC in the amount of \$167,026; and

WHEREAS, the Finance committee has reviewed and approved this project; and

WHEREAS, the overall project estimate is \$170,000 that was budgeted in the 2020 Capital projects budget: and

NOW, THEREFORE BE IT RESOLVED, by the Common Council of the City of Jefferson, Wisconsin that it herein authorizes the City Administrator to sign the contract to resurface the Jefferson Family Aquatic Center with Sonseeker Pool Masonry, LLC at a not to exceed \$167,026.

RESOLUTION OF EMERGENCY DECLARATION FOR THE CITY OF JEFFERSON

CITY OF JEFFERSON RESOLUTION NO. 93

EMERGENCY DECLARATION CITY OF JEFFERSON

WHEREAS, on this day, pursuant to the authority vested in the City of Jefferson Common Council under Chapter 323 of the Wisconsin Statutes and the City of Jefferson Emergency Management Ordinance Chapter 46, it is hereby declared that a Citywide State of Emergency exists in the City of Jefferson, and;

WHEREAS, the World Health Organization designated the COVID-19 pandemic as a Public Health Emergency of International Concern, and;

WHEREAS, COVID-19 is a contagious, and at times fatal respiratory disease, and;

WHEREAS, the worldwide Pandemic of COVID-19 and the effects of its extreme risk of person-to-person transmission throughout the United States significantly affect the life and health of our people, as well as the economy, and is a disaster that impacts the health, security, and safety of the public, and;

WHEREAS, the Governor of the State of Wisconsin declared a State of Emergency; the President of the United States has issued a Declaration of a National Emergency; and the United States Health and Human Services Secretary has declared a public health emergency for the entire United States to aid the nation's healthcare community in responding to COVID-19, and;

WHEREAS, with the need to be proactive and prepare, we, the Common Council of the City of Jefferson find that the potential for disaster exists which requires extraordinary measures to protect the health and well-being of our citizens. Declaring a State of Emergency will facilitate and expedite the use of resources to protect persons from the impacts of the spread of COVID-19 while maintaining continuity of operations for the City of Jefferson, and;

NOW, THEREFORE BE IT RESOLVED, by the Common Council of the City of Jefferson herein adopts the City Emergency Management Plan (CEMP) and authorizes the City Administrator and Police Chief, identified by City Ordinance 46 as Emergency Management Directors, all of the powers conferred upon them by the governing body of the City of Jefferson under all applicable statutes and ordinances, which within the discretion of the Emergency Managers appear necessary and expedient during said State of Emergency.
