### RESOLUTION TO AUTHORIZE HIRE OF A FULL-TIME WWTP OPERATOR

CITY OF JEFFERSON RESOLUTION NO. 27 **WHEREAS**, the position of Wastewater Plant Operator has been vacant since March, 2020 and it has been determined to be in the best interest of the Wastewater Utility that the position be filled when a qualified applicant has been identified; and

**WHEREAS**, the Personnel Committee has reviewed the candidacy and is recommending that Thomas Kutz meets the requirements of the position. The recommendation of the Personnel Committee is to hire Thomas Kutz to fill the vacant position of Wastewater Plant Operator; and

**NOW, THEREFORE BE IT RESOLVED**, by the Common Council of the City of Jefferson, Wisconsin that it herein approves and authorizes the hire of Thomas Kutz to fill the vacant position of Wastewater Plant Operator, subject to the following parameters:

- Thomas Kutz shall successfully pass a pre-employment physical and drug and alcohol screening.
- Thomas Kutz starting salary shall be \$26.59 per hour and be placed at Classification Six on the City of Jefferson Compensation Plan.
- Thomas Kutz will be placed on the PTO benefit schedule at the 5 of service step 14 days.
- Thomas Kutz shall start on or before September 8<sup>th</sup>, 2020.
