### RATIFYING A COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF JEFFERSON AND THE JEFFERSON PROFESSIONAL POLICE ASSOCIATION LOCAL #115

**WHEREAS**, the current Collective Bargaining Agreement between the City of Jefferson and the Jefferson Professional Police Association Local #115 expires at the end of day December 31, 2020; and

**WHEREAS**, the parties have negotiated a tentative agreement for a successor Collective Bargaining Agreement for the years 2021 and 2022; and

**WHEREAS**, the membership of the Jefferson Professional Police Association Local #115 have met and ratified the negotiated tentative agreement; and

**WHEREAS**, the Jefferson Finance Committee has met to consider the proposed tentative agreement and is recommending ratification of said tentative agreement to the Common Council; and

**NOW, THEREFORE BE IT RESOLVED**, by the Common Council of the City of Jefferson, Wisconsin that it herein approves and ratifies the tentative agreement for a successor Collective Bargaining Agreement between the Jefferson Professional Police Association Local #115 and the City of Jefferson. The Agreement includes the following major provisions:

- A two-year contract for years 2021 and 2022;
- A wage increase of 1% across the board for 2021
- A contractor reopener to bargain 2022 wages

## RESOLUTION APPROVING A RESTRUCTURED FAÇADE LOAN AGREEMENT WITH MIKE FOERSTER, TAMIKE INVESTMENTS, LLC

#### CITY OF JEFFERSON RESOLUTION NO. 51

**WHEREAS**, in February 2010 the City of Jefferson Redevelopment Authority approved a Façade Loan for 121 N. Main Street (Former Advertiser Building) in the amount of \$10,000 for the purpose of assisting the property owner with a variety of façade improvements;

**WHEREAS**, the terms and provisions of the loan include 2% interest to be paid annually with a balloon principle repayment due in year 10 or upon the sale of the property, whichever occurs first. The loan is secured by a Business Credit Agreement and a Real Estate Mortgage;

**WHEREAS**, the Manager of Tamike Investments, LLC., Mr. Michael Forester, has requested a one-year extension of the repayment of the loan principle due to the financial impacts of Covid-19;

WHEREAS, the City Attorney has drafted an Agreement of Modify and Extend A Business Credit Agreement which requires Tamike Investments, LLC to pay to the City the sum of \$1,200 representing the \$200 annual interest payment for 2020 and a \$1,000 reduction of principle balance on or before December 1, 2020. The balance of the loan shall accrue at the new interest rate of 5% per annum commencing on December 1, 2020. Tamike Investments, LLC shall make full repayment of the remaining principle on or before December 1, 2021, including all accrued interest and the balance of the loan;

**WHEREAS**, except as set forth in the Agreement to Modify and Extend a Business Credit Agreement, the terms and provisions of the original Business Credit Agreement are satisfied by the parties. The Agreement shall continue to be secured by a real estate mortgage dated February 24, 2010 and recorded with the Jefferson County Register of Deeds; and

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Jefferson, Wisconsin that it herein approves the Agreement to Modify and Extend a Business Credit Agreement between Tamike Investments, LLC and the City of Jefferson and authorizes the City Administrator to execute said Agreement on behalf of the City of Jefferson.

Ald. Neils, seconded by Ald. Beyer moved to approve Resolution No. 51. On call of the roll, Motion carried unanimously.

### RESOLUTION AUTHORIZING THE HIRE OF A FULL-TIME WWTP OPERATOR

#### CITY OF JEFFERSON RESOLUTION NO. 52

**WHEREAS**, the position of Wastewater Plant Operator has been vacant since November 2nd, 2020 and it has been determined to be in the best interest of the Wastewater Utility that the position be filled when a qualified applicant has been identified; and

**WHEREAS**, the Personnel Committee has reviewed the candidacy and is recommending that Mike Meske meets the requirements of the position. The recommendation of the Personnel Committee is to hire Mike Meske to fill the vacant position of Wastewater Plant Operator; and

**NOW, THEREFORE BE IT RESOLVED**, by the Common Council of the City of Jefferson, Wisconsin that it herein approves and authorizes the hire of Mike Meske to fill the vacant position of Wastewater Plant Operator, subject to the following parameters:

- Mike Meske shall successfully pass a pre-employment physical, drug and alcohol screening.
- Mike Meske's starting salary shall be \$26.00 per hour and be placed at Grade 6 on the City of Jefferson Compensation Plan.
- Mike Meske will be placed on the PTO benefit schedule at the 5 years of service step (14 days).
- Mike Meske shall start on or before December 1<sup>st</sup>, 2020.

Ald. Tully, seconded by Ald. Miller moved to approve Resolution No. 52. On call of the roll, Motion carried unanimously.
