ORDINANCE AMENDING SECTION 300-19B OF THE MUNICIPAL CODE OF THE CITY OF JEFFERSON RELATED TO REZONING IS AMENDED TO CHANGE DISTRICT BOUNDARIES OF 752 N. DEWEY AVE. FROM AG AGRICULTURAL DISTRICT TO THE ZONING DESIGNATION OF R-1 SINGLE-FAMILY RESIDENTIAL DISTRICT

### CITY OF JEFFERSON ORDINANCE NO. 2-21

The Common Council of the City of Jefferson, Wisconsin, do ordain as follows:

Section 1. Section 300-19 B. of the Zoning map, City of Jefferson, Wisconsin, which is herein made a part, is amended to change district boundaries of 752 N. Dewey Ave. from AG Agricultural District to the zoning designation of R-1 Single-Family Residential District.

Proposed Permanent Zoning Designation: R-1 Single-Family Residential District

Section 2. This ordinance shall take effect and be in full force after passage and publication as provided by law and notification and attestation of the district boundary changes incorporated herein the zoning map, City of Jefferson.

### ORDINANCE TO AMENDING § 270-3 OF THE JEFFERSON MUNICIPAL CODE

(To be introduced for its firs reading by Ald. Neils.)

### CITY OF JEFFERSON ORDINANCE NO. 3-21

**WHEREAS**, the City of Jefferson has previously enacted an Ordinance that regulates the business practices of Transient Merchants within the legal boundaries of the City of Jefferson; and

WHEREAS, questions have been raised as to what constitutes a Transient Merchant; and

**WHEREAS**, the Common Council of the City of Jefferson wishes to resolve these questions.

**NOW THEREFORE**, the Common Council does hereby ordain as follows:

Section 1. § 270-3(B) is amended to include the following definition:

<u>Pop-Up Retail Shop</u> – a retail enterprise that is opened temporarily to take advantage of certain trends or seasonal/holiday demand. Products offered for sale generally include handcrafted or art related items, apparel, toys, or other similar merchandise. Not included are the sale of fermented malt beverages, intoxicating liquor, wine, firearms, bows, or other weapons.

Section 2. Section 270-3(B) is hereby created to amend the definition of the term "Transient Merchant."

"Transient Merchant – Any individual who engages in the retail sale of merchandise at any place within the legal boundaries of the City of Jefferson, Wisconsin temporarily and who does not intend to become and does not become a permanent merchant of such place. For purposes of this section, 'sale of

merchandise' also includes a sale in which the personal services rendered upon or in connection with the merchandise sale constitutes the greatest part of value for the price received. Included in this definition are mobile dessert establishments, mobile food establishments, pop-up retail shops, and any other arrangements in which merchandise owned by a third party are sold at a local trade area owned or controlled by a permanent merchant."

<u>Section 3</u>. Section 270-3(D)3 is hereby amended to read as follows:

"At the time the registration is returned, a fee shall be paid by the applicant to the Clerk/Treasurer to cover the cost of processing the registration. For one sale event not exceeding three consecutive days, the initial fee shall be \$15.00 (for one event per year only). For all other sale events, the initial fee shall be \$50.00. The Common Council may adjust said fees on an annual basis. All permits issued under this Chapter shall expire on December 31 at 11:59 PM with no proration or reduction of the fee allowed."

<u>Section 4</u>. Except as stated herein, all other provision of §270-3 are hereby affirmed and shall be in full force and effect.

<u>Section 5.</u> This ordinance shall be effective on the date after its enactment and publication of this ordinance as required by law.

### AUTHORIZING AWARD OF CONTRACT FOR THE 2021 STREET & UTILITY IMPROVEMENTS

WHEREAS, the City of Jefferson received four bids from contractors interested in completing the **2021 STREET & UTILITY IMPROVEMENTS project for Plymouth Street**; and

**WHEREAS**, the value of the lowest bidder is included in the following table:

WHEREAS, Town & Country Engineering and City staff reviewed the project bid results and recommends award of the base bid and Alternates A and B and Supplemental bid items for the reconstruction of Plymouth Street; and

**WHEREAS**, the overall bid scope of work included a combination of storm sewer, pulverizing, milling, grading and resurfacing pavement as well as the installation of new water main and services in Plymouth Street; and

**WHEREAS,** of the total project bid amount of \$773,650, the streets and storm sewer portion of this bid totals \$444,464 with \$329,186 being associated with water main replacement; and

**WHEREAS,** monies for the project have been allocated in the 2021 Capital Budget and Storm Sewer Fund, 2021 Jefferson Utilities budget as well as CDBG grant funding;

**NOW, THEREFORE BE IT RESOLVED,** by the Common Council of the City of Jefferson, Wisconsin that it herein approves the Forest Landscaping & Construction Inc bid for the **2021 STREET & UTILITY IMPROVEMENTS** in the amount of \$773,650;

**BE IT FURTHER RESOLVED,** by the Common Council that the City Administrator is herein authorized and directed to execute any contract or document associated with the above action on behalf of the City of Jefferson upon the review and consent of the City Attorney and after execution of a signed CDBG agreement with the Department of Administration.

### RESOLUTION REVOKING A CLASS "A" INTOXIVATION LIQUOR LICENSE

### CITY OF JEFFERSON RESOLUTION NO. 87

**WHEREAS,** Casey's General Stores applied for a Class "A" Intoxication Liquor License for its store located at 507 S. Main Street, Jefferson, Wisconsin; and

**WHEREAS**, the Common Council of the City of Jefferson, Wisconsin approved said application on February 16, 2021 upon the recommendation of its Regulatory Committee; and

**WHEREAS**, §160-5L of the City of Jefferson's Code of Ordinance prohibits the sale of intoxicating liquor upon any premise where the sale of gasoline is conducted or carried on: and

**WHEREAS,** since the aforementioned applicant does, in fact, sell gasoline, the Common Council had no authority to authorize a Class "A" Intoxicating Liquor License to said applicant;

**BE IT FURTHER RESOLVED** by the Common Council, of the City of Jefferson, Wisconsin that the license granted on February 16, 2021 to Casey's General Stores is hereby revoked for the reasons set forth above.
