RESOLUTION AUTHORIZING RESURFACING OF NORTH JACKSON STREET FROM SPANGLER ROAD TO CITY LIMITS

RESOLUTION NO. 42**

WHEREAS, Jefferson County is preparing to resurface Hwy N north of the Jefferson city limits: and

WHEREAS, Jefferson County has provided an estimate in the amount of \$129,000 for Jefferson County to resurface North Jackson Street from the southern border of their jurisdiction to Spangler Road, measuring approximately 1,500 linear feet; and

WHEREAS, the City Engineer has reviewed the estimate and recommends resurfacing of North Jackson Road by Jefferson County due to the condition of the pavement while taking advantage of the reduced cost in paving due to the Jefferson County resurfacing of Hwy N; and

WHEREAS, this project is unbudgeted and will be paid out of fund balance;

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Jefferson, Wisconsin that it herein authorizes the City Administrator to execute a contract with Jefferson County in the amount of \$129,000 to resurface North Jackson Street from Spangler Road to the northern city limits of Jefferson.
