### AN ORDINANCE AMENDING SECTION 300.02.70 (RA-35) RURAL HOLDING ZONING DISTRICT OF THE CITY OF JEFFERSON CODE OF ORDIANCES

#### CITY OF JEFFERSON ORDINANCE # 1-23

The Common Council of the City of Jefferson (the City), Wisconsin, hereby ordains as follows:

**Section 1.** §300.02.70 is hereby amended to include the following as a permitted use in a Rural Holding Zone:

(p) Golf Course and related activities.

§300.02.70 is hereby further amended to include the following as a conditional use in a Rural Holding Zone:

(x) Golf Course Maintenance, Food Snack Shed, and Pro Shop.

All other provisions of §300.02.70 are hereby reaffirmed.

**Section 2.** This ordinance shall take effect after the passage, publication, and attestation as required by law.

#### RESOLUTION AUTHORIZING COMPENSATION FOR THE CITY ADMINISTRATOR

(To be introduced by Ald. Teeter.)

#### CITY OF JEFFERSON RESOLUTION NO. 80

**WHEREAS**, the City of Jefferson has adopted a Compensation Plan (the Plan) covering many of its non-represented municipal employees; and

**WHEREAS**, the City Administrator position is not a classified position on the adopted Plan.

**WHEREAS**, the Personnel Committee requested that Carlson Dettmann conduct a labor analysis for the Administrator position and subsequently have reviewed the compensation analysis with the Finance Committee; and

**NOW, THEREFORE BE IT RESOLVED,** by the Common Council of the City of Jefferson that it herein sets the 2023 compensation at \$135,500 for the City Administrator position. Said pay should be retroactive to January 1, 2023.

Ald. Teeter, seconded by Ald. Brandel moved to approve Resolution No. 80. On call of the roll, Motion carried unanimously.

## RESOLUTION AUTHORIZING AMENDMENT OF CONTRACT BETWEEN CITY OF JEFFERSON AND MUNICIPAL ZONING AND INSPECTION SERVICES

(To be introduced by Ald. Tully.)

#### CITY OF JEFFERSON RESOLUTION NO. 81

**WHEREAS**, the City of Jefferson contracts with the Municipal Zoning and Inspection Services (MZIS) for zoning and inspection services; and

**WHEREAS,** the scope of services performed by (MZIS) for the City of Jefferson includes providing inspection of construction, energy, heating, venting and air conditioning, electrical, and plumbing improvements, as well as zoning administration related services; and

**WHEREAS**, the contract currently in place between the parties was last updated in 2016 and established annual compensation for MZIS at \$70,000. MZIS has requested that the annual compensation be increased to offset its operating cost increases since 2016; and

**WHEREAS**, the parties have negotiated an increase in annual compensation that would provide for an increase of 15% (\$10,500) which would increase the MZIS annual compensation to \$80,500; and

**WHEREAS**, the Finance Committee has reviewed this matter and is recommending that the annual MZIS compensation for services provided be increased to \$80,500; and

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Jefferson, Wisconsin that it herein approves an amendment to the City's existing contract with MZIS that would adjust its annual compensation for services provided to \$80,500.

Ald. Tully, seconded by Ald. Beyer moved to approve Resolution No. 81. On call of the roll, Motion carried unanimously.

Ald. Lares, seconded by Ald. Neils moved to adjourn the Jefferson Common Council Meeting at 7:24 p.m., carried unanimously on a voice vote.
