RESOLUTION AUTHORIZING A PERSONNEL POLICY AND PROCEDURE MANUAL FOR THE JEFFERSON FIRE AND EMS DEPARTMENTS

(To Be introduced by Ald. Tully.)

CITY OF JEFFERSON RESOLUTION NO. 64

WHEREAS, the City of Jefferson will look to consolidate the Jefferson Fire Department and EMS Department into one operating department under a unified command structure during the first quarter of 2024; and

- **WHEREAS**, the purpose of this consolidation is to implement the 2023 Referendum which will provide the financial resources required to begin the process of hiring a limited number of full-time firefighter-emergency medical personnel to augment the City's volunteer-based fire department; and
- **WHEREAS**, it was determined that to consolidate the operations of the two departments the City should adopt a Personnel Policy and Procedure Manual that would be applicable to Fire Department and EMS Department employees; and
- **WHEREAS**, the Manual has been prepared to inform Fire/EMS Staff of various City policies and to provide for the orderly and efficient operation of the City; and
- **WHEREAS,** the Personnel Committee has reviewed the Manual and is recommending its adoption to the City Council; and
- **NOW, THEREFORE BE IT RESOLVED,** by the City Council of the City of Jefferson, Wisconsin that it hereby adopts the City of Jefferson Firefighters and EMS Manual as reviewed and recommended by the Personnel Committee.
- **BE IT FURTHER RESOLVED** by the City Council that the Manual will become effective upon the date of reorganization as determined by the Personnel Committee, but in no event shall this date be later than April 1, 2024.

Ald. Tully, seconded by Ald. Stone moved to approve Resolution No. 64. On a call of the roll, the motion was carried unanimously.

RESOLUTION AUTHORIZING TO PROCURE TAX INCREMENT DISTRICT AND DESIGN ENGINEERING PROFESSIONAL SERVICES

CITY OF JEFFERSON RESOLUTION NO. 65

- **WHEREAS**, the City of Jefferson and Jefferson County have been working cooperatively to plan for the development of a Food and Beverage Innovation Campus on a large tract of land owned by Jefferson County located within the southerly corporate limits of the City of Jefferson; and
- **WHEREAS,** a large company (the Company) has recently expressed an interest in constructing a large manufacturing facility on approximately 100 acres of land located within the proposed Food and Beverage Innovation Campus; and
- **WHEREAS**, the Company and Jefferson County have entered into a "Letter-of-Intent" agreement regarding the purchase of this property and are currently negotiating a "purchase contract" which would transfer ownership of this property to the Company; and
- **WHEREAS**, the timetable for the Company to begin construction of their facility is aggressive with construction to begin in 2024; and

WHEREAS, development of the Food and Beverage Innovation Campus and the infrastructure required to serve the Company will require the installation of significant public improvements, including street and utility extensions, wastewater lift station, and electric power line relocations; and

WHEREAS, the City will be responsible for planning, constructing and funding the installation of public improvements serving the Food and Beverage Innovation Campus and anticipates that a new Tax Increment District will be required to fund this portion of the project; and

NOW, THEREFORE BE IT RESOLVED, by the City Council of Jefferson, Wisconsin that it herein authorizes the City Administrator to begin the process of creating a Tax Increment District to facilitate construction of the public improvements required to serve the Food and Beverage Innovation Campus via contract with Ehlers and Associates and commence work on the design engineering required for the public improvements by contract with Town and Country Engineering; and

BE IT FURTHER RESOLVED, by the City Council that the City Administrator's authorization to proceed is contingent upon the Company and Jefferson County entering in a formal "offer-to-purchase" contract for the sale of property.

Ald. Neils, seconded by Ald. Mattke moved to approve Resolution No. 65. On a call of the roll, the motion was carried unanimously.

RESOLUTION AUTHORIZING THE HIRE OF A PART-TIME PATROL OFFICER

CITY OF JEFFERSON RESOLUTION NO. 66

WHEREAS, Police Chief Richter has taken steps to fill a vacant position in the Police Department for a part-time patrol officer; and

WHEREAS, The part-time patrol officer position requires successful completion of basic law enforcement training; and

WHEREAS, the position was publicly advertised and interviews were conducted with five potential candidates of seven applicants; and

WHEREAS, Police Chief Richter is recommending that Cameron Reinders be hired by the City of Jefferson to fill the vacant position; and

WHEREAS, the Personnel Committee having reviewed the qualifications of Cameron Reinders and pursuant to Chief Richter recommending the hire of Cameron Reinders as a Part-time Patrol Officer for the City of Jefferson Police Department to the Common Council; and

WHEREAS, the Chief of Police has part-time funds allocated in his 2024 approved operating budget and that this part-time patrol officer is to replace vacancies in the part-time patrol officer staffing levels;

NOW, THEREFORE BE IT RESOLVED, by the Common Council of the City of Jefferson, Wisconsin that the Chief of Police is authorized to hire Cameron Reinders as a Part-time Patrol Officer, effective upon his successful completion of a 720-hour basic law enforcement recruit academy in May of 2024, as a part-time patrol officer for the City of Jefferson Police Department. The initial rate of pay shall be \$24.46 per hour pursuant to the 2024 City of Jefferson non-represented pay resolution.

Ald. Mattke, seconded by Ald. Tully moved to approve Resolution No. 66. On a call of the roll, the motion was carried unanimously.
